- 2) I confirm that I accept the prize as presented to me, that it cannot be substituted for another prize or exchanged, in whole or in part, for cash.
- 3) I confirm that receipt of the prize by me fully discharges and releases the NRRM and its elected officials, officers, employees and agents from and against any and all liabilities, losses, claims, demands, costs and expenses (including lawyer's fees and litigation expenses on a solicitor and client basis) whatsoever relating to the participation in the Contest, participation in any of the Contest related activity or the acceptance, and use or misuse of the Prize, including but not limited to losses related to personal injuries, death or damage to or loss or destruction of the property.
- 4) If I am a group representative accepting the prize on behalf of an unincorporated group participating in the Contest (the "Group"), I hereby indemnify and save harmless the City and its elected and appointed officials, employees, contractors and agents, from and against all claims, losses, damages, costs, expenses (including legal fees and disbursements on a solicitor and own client basis), liabilities, actions and proceedings, suffered, made, incurred, sustained, brought, prosecuted, threatened to be brought or prosecuted, or in any manner caused, based upon, occasioned by or attributable to any legal action brought by other members of the Group against the NRRM for any reason related to the participation in the Contest, participation in any of the Contest related activity or the acceptance, and use or misuse of the Prize, including but not limited to losses related to personal injuries, death or damage to or loss or destruction of the property.

 - b) I have reached the age of 19 or I have a parent or guardian who represents me and signs this Declaration and Release on my behalf;
 - c) I have complied with the Contest Rules and I have answered the skill testing question in the manner prescribed in the Contest Rules;
 - d) The terms of the Contest Rules and this Declaration and Release apply to and are binding on me, and my respective heirs, executors, administrators, personal representatives and assigns;
 - e) This Declaration and Release is, to the best of my knowledge and belief, true and accurate; and
 - f) By signing this Declaration and Release I confirm that I have read, understood and agreed to be bound by the Contest Rules and this Declaration and Release.
